#### Dear ULTRIX and UWS Customer:

Thank you for purchasing Digital's ULTRIX and ULTRIX Worksystem Software (UWS) Version 4.5 product. Please ensure that you have the appropriate license for the software that you intend to use; you can obtain a license from your Digital sales representative. To use the ULTRIX operating system, you need an ULTRIX license. To use UWS on a workstation, you need a UWS license. To use UWS on a system other than a workstation, you need an ULTRIX license plus a UWS Server license. To use DECnet/OSI for ULTRIX, you need the appropriate DECnet license.

The ULTRIX and UWS Version 4.5 product is released for both RISC and VAX customers.

The ULTRIX and UWS Version 4.5 product is a maintenance release. See the *ULTRIX and UWS Release Notes* for complete information on the software problems fixed in this release.

#### Distribution Media

The ULTRIX and UWS Version 4.5 software is available on tape and CD-ROM distribution media.

The RISC and VAX tape media for the supported software contains the ULTRIX and UWS software. Additional tapes contain the ULTRIX unsupported software and the Boot/Upgrade software.

The RISC and the VAX CD-ROMs contain the ULTRIX and UWS supported software and the unsupported software. There is no Boot/Upgrade software required for CD-ROM distribution.

#### Software Product Descriptions

The Software Product Descriptions (SPDs) for the ULTRIX and UWS products are shipped in software subsets on the tape and CD-ROM distribution media. When these optional subsets are installed, text and PostScript versions of the SPDs are produced. You can print or view the SPDs. See the *ULTRIX and UWS Release Notes* for more information about the SPD subsets.

If any items are missing or damaged, or if you find any defective media during the installation process, contact your Digital sales representative. The first line of the label lists the part number you need to order the replacement item.
- Read the *ULTRIX and UWS Version 4.5 Release Notes* and the *ULTRIX and UWS Version 4.5 System Notes* and the *Guide to Installing ULTRIX and UWS* for important information that will help ensure a successful installation. In particular, please note information about installations, upgrades, and layered products in these manuals.

The ULTRIX and UWS Version 4.5 product does not change the License Management Facility (LMF) for user capacity upgrades. Therefore, customers do not need new Product Authorization Keys (PAKs).

The ULTRIX and UWS Version 4.5 software comes with a warranty as described in the Software Product Description (SPD for ULTRIX 26.40.32, SPD for UWS 28.22.25) addendum. If the ULTRIX and UWS Version 4.5 software fails to perform, contact your Digital sales representative to start the problem-resolution process.

If you already have a Digital software support contract, your contract remains in effect. If you would like to purchase a Digital support contract or additional support services, contact your Digital sales representative.
